GENERAL TERMS OF SERVICES

The present terms and conditions are an integral part of the offers and of any agreement for sale of products or services made by LUX LANGUES SA, a Luxembourg company,

headquartered at 5, rue de Hesperange, L-7131 LUXEMBOURG CITY.

For the contractual relationship between LUX LANGUES SA, it center of Luxembourg (hereinafter "the provider") and the physical or legal persons who use the services of the latter(hereinafter 'the customer') only these general conditions in the official version at the time of concluding the contract are valid. The provider does not recognize derogatory conditions on behalf of the customer, unless the supplier has expressly agreed in writing to their validity. The customer is presumed to have read the general terms and conditions and to have accepted all their clauses.

All the offers of products and services made by the provider are valid for a period of 1 year. The current tariff comes into force on 1.1.2021 for any training after this date, regardless of the date booking, until 31/12/2021.

The prices stated in our brochures and other literatures are valid for a period of 1 year from the date of entry into force of the tariff. Our prices include VAT. VAT regulations in effect on the date of registration will apply. The VAT system applied will be based on the information submitted in good faith by the customer. However, we reserve the right to modify the prices and our terms and conditions at any time of the year without notice. Only the price and general conditions mentioned on the websitewww.inlingua.lu or via our brochures (in pdf and paper format) at the time of registration will apply. The customer may at any time ask to be sent the tariffs by contacting us via infoinlingua@inlingua.lu.

Our invoices are payable upon receipt by the customer. In case of registration less than 7 days before the seminar/course, registration fees are payable immediately and the customer will be asked to send proof of payment. THE ENTIRE COST OF THE KID AND TEENS TRAINING MUST BE PAID BEFORE THE BEGINING OF THE COURSE.

Registration for an inlingua® course is only binding upon receipt and acceptance by the Customer Service of Lux Langues SA of the registration duly completed and signed or a signed quote sent via our website. Acceptance of registration is indicated by sending a confirmation via e-mail, accompanied by a precise description of the product or service ordered, with confirmation of our general terms and conditions as well as an invoice.

We reserve the right to cancel any course for which the payment of the deposit has not been made or for which proof of payment does not reach us in time.

5. COOLING-OFF PERIOD - WITHDRAWAL

The customer has the right to notify that he is cancelling his order, without penalty and without giving any reason, within a cooling-off period of 14 working days from the day following the date of receipt of the confirmation of the final registration for an inlingua® course.

After this cooling-off period, any withdrawal of an order for inlingua® services will result in the application to the customer of the conditions in paragraph 6. However, this right of withdrawal cannot be exercise by the customer when registering for a course starting before the end of the 14-day cancelation period.

6. CANCELLATION OR POSTPONEMENT

If a customer cancels less than 15 days before the start of his language course, he will be charged an amount equivalent to 50% of the total amount charged, as a lump cancellation fee. These fees will rise to 75% of the total amount charged for cancellations or postponement made less than 7 days before the course starts. The entire course fee is payable if the customer does not show up. In the event of departure or of absence of the customer from the course, the entire seminar, internship, course or training course, will remain payable in full. Absences cannot be compensated for by attendance at an equivalent course.

In case of postponement, our conditions and particularly article 3 (terms of payment) remain applicable. Compensation does not apply in case of force majeure. In this case, we will ask for a written proof attesting to the force majeure. Any postponement or cancellation must be effected in writing to the Customer Service department of LUX LANGUES SA or to the concerned training center.

7. RESPONSABILITY

The legal guardian states to take any responsibility relating to his son/daughter during the training course and agrees to pay the course fees. LUX LANGUES SA and its employees are responsible for the service and cannot be held accountable for the possible physical injuries related to the participation of minors in these training courses. The legal guardian remains solely responsible for these injuries. These clauses apply for all circumstances except for those due to the negligence of an employee of the LUX LANGUES SA company, inlingua® Luxembourg or other providers of the service.

The legal guardian authorizes:

- •The person in charge of the training course to take, if necessary, any medical measurement made necessary by the health of the child.
- · Discharge of the trainers and the LUX LANGUES SA staff of any responsibilities for any flight and loss of a personal object
